We/I further agree that we/I shall not hold liable the Borough of Tenafly, the Tenafly Recreation Commission, and its agents, servants or employees in the event of an accident, other loss or damage that might be sustained by me or my child as a result of my/my child's attendance and participation at the Tenafly Skate Park. This covenant may be used by the Borough of Tenafly as a defense to any action or proceeding that may be brought or instituted by me/my heirs or legal representation in breach of this agreement.

We/I agree that I/my child am/is physically able and in normal health and have/has not been otherwise informed by a physician that I/my child am/is incapable of participation in any leagues, clinics, classes, tournaments or activities at the Tenafly Skate Park that may include strenuous physical activity. I fully understand that the risk of injury from the activities and programs provided at the Tenafly Skate Park may be significant. The risk of injury includes, but is not limited to, minor injury such as abrasions and bruises, and more serious injury such as broken bones, muscle pulls and dislocations. The risk of injury also includes catastrophic injury such as permanent paralysis or even death. With full knowledge of the potential risk for injury, I hereby give my consent to participate and/or give my child permission to participate and represent that I have full legal authority to provide such consent.

In addition, I fully understand and will abide by all rules and regulations as stated below and posted at the Tenafly Skate Park:

- No one is allowed to participate in the activities of the skate park unless they are wearing ALL of the required protective gear.
- The skate park is a skate at your own risk facility designed for skate boarding and inline skating only. The skate park will not be supervised. Users will skate at their own risk.
- All participants must skate in a manner as to avoid collision with other participants. Fighting or other aggressive or disruptive behavior will result in ejection from the skate park and possible revocation of membership card.
- No one is allowed to participate in the activities of the skate park unless they have registered with the Tenafly Recreation Department and they have a signed participant release of liability form on file.
- No organized events or contests of any kind are allowed in the skate park unless organized and administered by the Tenafly Recreation Department.

# Tenaflly Skate Park

## Rules & Regulations

- All users must register and obtain a badge from the Tenaflly Recreation Department.
- The skate park is a skate at your own risk facility, designed for skateboarding and inline skating only. The skate park will not be supervised. Users will skate at their own risk.
- All skaters must wear helmets, elbow pads, kneepads and wrist guards.
- Bicycles and motorized vehicles are NOT permitted in the park at any time.
- Only skaters are permitted inside the enclosed skate park area. All spectators must remain outside the enclosed area.
- All participants must skate in such a manner as to avoid collision with other skaters, fighting and other aggressive or disruptive behavior will result in ejection from the park.
- No food or drink is permitted inside the skate park.
- Littering, glass containers, alcoholic beverages, pets, radios or boom boxes are prohibited. Radios or CD's with ear phones for private listening are allowed.
- Shirts must be worn inside the skate park. Proper shoes must be worn while skateboarding.
- Smoking is not permitted anywhere within the skate park. Use of profanity or abusive language and/or vandalism is strictly prohibited.
- No organized events or contests of any kind are allowed in the skate park unless organized and administered by the Recreation Department.
- No skating is permitted when equipment is wet and/or icy. The skate park will be closed during rain, snow or ice conditions.
- Skateboarding is prohibited outside the enclosed skate park.
- The skate park will be open, weather permitting, during the posted hours only:
  - Monday to Friday - 3:00 p.m. to dusk school days
  - Monday to Friday - 10:00 a.m. to dusk non-school days
  - Saturday - 10:00 a.m. to dusk
  - Sunday - 1:00 p.m. to dusk
