Not withstanding the above fee schedule, no permit fee shall be required for the removal of a dead or hazardous tree located within the buffer area, provided the applicant and/or property owner satisfies all of the other requirements of the ordinance and the provisions of Resolution #R02-194 adopted June 25, 2002.

**H. Notice or Consent of Adjoining Property Owner (If Required)**

In the event the Director of Public Works determines that any tree to be removed is located within the buffer area or in close proximity to the property line between the two properties, the applicant is required to notify the owner of the adjacent property by letter or personal contact and the applicant shall be required to submit written evidence of such notification at the time of application for a tree removal permit. In addition, in the case of any tree shown on a survey plan located on a property line, the applicant shall be required to obtain written consent from the adjacent property owner to remove said tree and said written consent shall be submitted by the applicant at the time of application for a tree removal permit.

**I. Tree Removal Plan**

Attach an original and two (2) copies of a tree removal plan consisting of a map drawn to scale showing the location of all trees on the property of a caliper of six (6) inches or greater, and the location of all trees to be removed, the species of such trees, and their caliper. The tree removal plan must be prepared, signed and sealed by a licensed professional engineer or land surveyor, and must show the location of all existing and proposed structures on the property, together with the distance, up to fifteen (15) feet, that the trees proposed to be removed are located from such structures and from property lines.

As a precondition to the issuance of a permit where mitigation is required, the applicant shall post a cash bond to assure mitigation in an amount equal to \$ 125.00 for each minor tree and \$250.00 for each major tree to be planted. The bond shall be returned to the applicant upon the completion of the required mitigation as provided in the ordinance.
