If you are renewing from the previous year the following will apply to you. **YOU MUST LICENSE BEFORE MARCH 1<sup>ST</sup> of current LICENSING YEAR.** If no license is obtained a:

A **summon fee** of \$59.00 (each Pet) **will be issued on March 1<sup>st</sup> for all unlicensed animals** and a **late fee** for renewals obtained on or after March 1<sup>st</sup> is \$10.00 additional for each month or part thereof until said license and registration tag are obtained.
